PUBLIC HEARING

On Closing Capital Repair Reserve Account

October 22, 2025

Meeting was called to order at 6:10 p.m.

This public hearing is to allow the public to voice their opinion regarding closing our Capital Repair Reserve account and depositing the funds into our Capital Reserve account.

WHEREAS, the Board of Fire Commissioners of the Barnard Fire District created pursuant to Section 6-d of the General Municipal Law a repair reserve fund known as the Capital Repair Reserve Fund, and

WHEREAS, the Board of Fire Commissioners of the Barnard Fire District created pursuant to Section 6-g of the General Municipal Law, the Capital Reserve Fund for the purchase and acquisition of firefighting apparatus, firefighting equipment, building improvements, and EMS equipment

WHEREAS, pursuant to Section 6-d of the General Municipal Law a public hearing is required to expend monies from any repair reserve fund, and any sums therefrom can be appropriated to a capital fund established pursuant to General Municipal Law Section 6-g.

NOW, THEREFORE, BE IT RESOLVED that the sums in the Capital Repair Reserve Fund, subject to a public hearing on the question, are hereby transferred to the Capital Reserve Fund, and
